Individuals who finished in the Top 25 of the 2008 points list in either Southern Texas PGA or Northern Texas PGA may not form a team. A-3 Members are considered in the top 25. FIELD LIMIT: The first 60 teams with **paid** entries.

SPECIAL EVENTS: Skills Competition will be conducted after completion of Round 1.

HOTEL ACCOMMODATIONS: Hyatt Regency Hill Country Resort - \$139.00 per night for single or double occupancy. Identify yourself as being with the Southern Texas PGA. Phone Number – 1 (800) 554-9288. Rooms are being held until 5:00 pm, Monday, November 28th, 2008.

DEADLINE: Entries must be received by 5:00 p.m. Wednesday, December 3rd by the Southern Texas PGA. In the event the field is full before the posted deadline, an alternate list will be kept on a first come first serve basis.

CONDITIONS OF COMPETITION:

NON-METAL SPIKE POLICY- As a condition of this competition all participants shall wear spikeless/non-metal spike golf shoes. In consideration of participation, participants hereby release and hold harmless the Southern Texas PGA, Northern Texas PGA and Hyatt Hill Country Resort from any and all claims for loss or damage whether or not caused by participants use of spikeless/non-metal spike golf shoes. Penalty for non-conformance is disqualification. (Spikeless cleats with metal stud insert do not conform.)

ALCOHOL CONSUMPTION POLICY- Consuming any alcoholic beverage on the course from tee time until the scorecard is turned in is prohibited.

DRESS CODE- Proper golf attire is required for professionals. Appropriate dress will consist of slacks and shirts with collars and sleeves. Shorts, blue jeans, collarless T-shirts and tank tops will not be allowed. This dress code will be in effect during any practice rounds.

SEPARATE TEES/SAME PURSE-

1. Senior Male Professionals (60 and older) will play from a distance approximately 94% of the men's tee yardage.
2. Female Professionals will play from a distance approximately equal to 85% of the men's tee yardage.
3. Although competing from separate tees, men and women professionals shall compete for the same purse.
